9:00AM Brightstar Resources (BTR)

Brightstar Resources is an emerging gold producer with a million ounces of mineral resources located in Western Australia's eastern goldfields and Murchison districts. Brightstar has an operational aspiration of becoming a +200koz per annum producer within 4 years.

9:30AM Santana Minerals (SMI)

Santana Minerals is focused on developing the Bendigo-Ophir gold project in Central Otago, New Zealand into an environmentally responsible, economically sustainable mining project bringing inter-generational employment and prosperity to the region.

10:00AM Alkane Resources (ALK)

Alkane Resources is an ASX and TSX listed Australian gold producer and explorer. Alkane has 3 operating mines, two in Australia, and one in Sweden. Alkane's guidance is 160-175koz (antimony by-product) this financial year. Alkane also has a large Australian Au-Cu porphyry project with ~15Moz in indicated and inferred resource.

10:30AM Regis Resources (RRL)

Regis Resources is one of Australia's largest, unhedged gold producers, with 100% of production from West Australian assets and over a decade of consistent production and reserve growth, underpinned by continued exploration success and targeted acquisitions.

11:00AM Capricorn Metals (CMM)

Capricorn Metals is an Australian based gold producer headquartered in Perth, Western Australia. The company operates within two distinct project areas within Western Australia, with a total resource base of 6.6 million ounces and reserves of 4.0 million ounces.

11:30AM Catalyst Metals (CYL)

Catalyst Metals is an Australian gold producer with a low-cost organic growth pipeline. Its flagship 40km Plutonic Gold Belt in Western Australia hosts the Plutonic Gold Mine, producing ~85koz per annum at ~A\$2,400/oz AISC, with plans to advance three new projects over the next 12-18 months.

1:00PM Great Boulder Resources (GBR)

Great Boulder Resources is a high-impact gold explorer focused on resource growth at its flagship Side Well Gold Project in the Murchison region of Western Australia. With strong cash reserves, the company is targeting a 1.5Moz gold resource and advancing towards pre-feasibility in a premier gold district.

2:00PM Ballard Mining (BM1)

Ballard Mining is an exploration and development company advancing the Mt Ida Gold Project towards production. The project hosts a high-grade 1.1Moz resource at 3.3g/t and is fully approved for open pit and underground mining, with ongoing drilling aimed at resource confidence and growth.
